

I. Executive Summary

MED-Project LLC ("MED-Project") operates a Product Stewardship Plan for unwanted Medicine from Households dated August 31, 2022 ("Approved Plan") in Alameda County ("Jurisdiction") under the Alameda County General Ordinance Code, Chapter 6.53, the Alameda County Safe Drug Disposal Ordinance ("Ordinance") and the Alameda Safe Drug Disposal Regulations ("Regulations"). This 2023 Alameda County Unwanted Medicine Annual Report ("Report") describes MED-Project's activities between January 1, 2023, and December 31, 2023 (the "Reporting Period"). All capitalized terminology not defined in this summary is derived from the Approved Plan.

MED-Project has served the Residents of Alameda County since 2015, including collecting over 355,000 pounds of Unwanted Medicine. MED-Project's comprehensive outreach and education program has generated over 87 million impressions to County Residents.

A. Notifications in the Reporting Period

MED-Project submitted one notification to the Alameda County Department of Environmental Health ("Department") during the Reporting Period:

- On June 26, 2023, MED Project submitted a Substantive Change Request, requesting approval of utilizing Municipal Waste Combustor disposal sites, which was approved by the Department on August 30, 2023.
- On September 4, 2023, MED-Project submitted a Petition for Exception to use the Host-Assisted Collection Kiosk Drop-Off Sites listed in the Petition for Exception. On September 7, 2023, the Department approved the Petition for Exception.

B. Reporting Period Operations Overview

During the Reporting Period, priority was given to establishing Kiosk Drop-Off Sites throughout the Jurisdiction, and performing outreach to eligible pharmacies, hospitals,

and clinics with on-site pharmacies, and Law Enforcement Agencies ("LEAs"). During the Reporting Period, MED-Project's Program collected and disposed of Unwanted Medicine from 99 Kiosk Drop-Off Sites. MED-Project installed four new Kiosk Drop-Off Sites throughout the Jurisdiction during the Reporting Period.

Kiosks were installed in pharmacies that meet all local, state, and federal requirements and that executed agreements with MED-Project. In addition, outreach and educational materials, including signage and/or brochures, were distributed to new Kiosk Drop-Off Sites.

MED-Project provided disposal instructions for Kiosk Drop-Off Sites and Mail-Back Services to Residents and continues to communicate with Kiosk Drop-Off Site Hosts to distribute outreach materials upon request, review procedures as needed, and improve overall Program design.

As outlined in the Approved Plan, the ultimate goal of the Program is to provide Residents with convenient, safe, and accessible methods to dispose of Unwanted Medicine.

The following Sections of the Report respond to specific reporting requirements in Ordinance Section 6.53.080 and Regulations Section 15. Each section of the Report restates the corresponding Ordinance and Regulations requirements and provides the required information. All figures are rounded to the nearest tenth place.

MED-Project collected Unwanted Medicine during the Reporting Period, utilizing Kiosk Drop-Off Sites, and Mail-Back Packages distributed from the MED-Project Website and Call Center.

IV. Kiosk Drop-Off Locations, Mail-Back Distribution and Take-Back Events

A. Kiosks

MED-Project collected a total of 71,829.1 pounds of Unwanted Medicine through Kiosk Drop-Off Sites.

B. Mail-Back Packages

- MED-Project collected a total of 14.8 pounds of Unwanted Medicine through the return of 14 Inhaler Mail-Back Packages.
- MED-Project collected a total of 44.4 pounds of Unwanted Medicine through the return of 88 Standard Mail-Back Packages.
- MED-Project collected a total of 59.2 pounds of Unwanted Medicine through the return of Mail-Back Packages during the Reporting Period.

C. Total Weight of Collected Unwanted Medicine

MED-Project collected a total of 71,888.3 pounds of Unwanted Medicine through all methods.

V. Kiosk Drop-Off Locations, Mail-Back Distribution, and Take-Back Events

There were no mail-back distribution locations in the Jurisdiction during the Reporting Period. Mail-Back Packages can be ordered anytime by any Alameda Resident via the MED-Project Website or Call Center.

C. Number of Mail-Back Packages Distributed and Returned

MED-Project distributed 226 Standard Mail-Back Packages and 30 Inhaler Mail-Back Packages for a total of 256 Mail-Back Packages distributed directly to Residents. MED-Project identifies a total number of Mail-Back Packages provided directly to Residents because it is unable to verify whether the recipient is home-bound or underserved. For information on the number of Mail-Back Packages returned, see Section IV.B Mail-Back Packages.

There were no Take-Back Events during the Reporting Period.

The Condition requires "The annual report must reflect all pertinent information regarding the new disposal facility sites (ex. Safety and Security Report, Plan Deviation Report, etc." MED-Project is not aware of any violations, safety and security problem, or plan deviations involving the two facilities listed below.

IX. Educational Efforts and Public Outreach

A. Public Education Activities

MED-Project provided instructions for Kiosk Drop-Off Sites, and Mail-Back Services to Residents during the Reporting Period. In addition, MED-Project maintained the MED-Project Website and toll-free Call Center to provide information pertaining to MED-Project disposal options and outreach materials. The website, toll-free number, and promotional materials, such as posters and brochures, were available in English, Spanish, Chinese, Tagalog, and Vietnamese. See Appendix G for screenshots of MED-Project Website pages and Appendix H for MED-Project Website page statistics.

B. Outreach Activities

MED-Project conducted the following outreach activities during the Reporting Period: provided radio, connected TV, streaming radio, and digital advertising campaigns; distributed signage and brochures; posted information on social media platforms and to the MED-Project Website; and, sent email blasts. As a part of outreach activities described above, MED-Project generated more than 3.9 million total impressions during the Reporting Period. A list of the social media and email outreach promotion activity is provided in Appendix J. The reach percentage for each campaign is provided in the Media Outreach Summary. See Appendix J.

C. Evaluation Activities

In 2023, MED-Project ran a campaign across both digital display media and sponsored social media. The campaign utilized behavioral, interest, and search targeting to reach intended audiences researching topics including prescription drugs, drug disposal, prescription purchase data, pharmacy websites, and prescription drug-related keywords. The campaign was designed to maximize reach among the target audience, allowing for the opportunity to maximize awareness.

X. Program Goals

A. Collection Goals




Figure 1: Map of Active Kiosk Drop-Off Sites

MED-Project operated 99 Kiosk Drop-Off Sites of the 100 Kiosk Drop-off Sites discussed in the short-term goal that are to be distributed jointly, in combination with other approved product stewardship programs across the County, as outlined in the Approved Plan. Figure 1 shows a visual representation of how MED-Project met the short-term collection goal during the Reporting Period.

Efforts to meet the long-term goals included accepting additional potential Kiosk Drop-Off Sites that are eligible and request participation in the Program as well as reducing collection through Take-Back Events and/or Mail-Back Services. Mail-Back Packages can be ordered anytime by any Alameda Resident via the MED-Project Website or Call Center. MED-Project operated 99 Kiosk Drop-Off Sites during the Reporting Period. No Take-Back Events were needed during the reporting period.

B. Education and Public Outreach Goals

MED-Project met the Approved Plan's short-term and long-term goals by continuing a media program that is consistent with Regulations Section 8.A.viii via the MED-Project Website, Call Center and media campaigns. On an ongoing basis, MED-Project may revise and add promotional materials based on changes to the Approved Plan.

Appendix D

Safety and Security Report

Event: Unwanted Medicine Shipping Discrepancies boxes and liners declared by carrier to be lost in transit.

Date: May 2, 2023, and September 26, 2023

Description: The reverse distributor vendor ("Vendor") reported that two Unwanted Medicine Boxes and Liners that originated from Kiosk Drop-Off Sites in Alameda County, California during the reporting period were not received at the Vendor location. The Carrier declared the Boxes and Liners to be lost in transit.

MED-Project understands that there have been rare exceptions in which the Carrier cannot deliver a package to its destination or return it to the shipper for reasons including, but not limited to, the loss of shipping information, such as a damaged shipping label. The Vendor has reported that the Carrier has policies and procedures for managing such packages, including destruction at a permitted medical waste incinerator.

These events were reported by MED-Project to the Alameda County Department of Environmental Health on May 24, 2023, and October 8, 2023, respectively.

Corrective Action Taken: MED-Project requested that the Vendor provide a detailed report of its investigation and findings and keep MED-Project apprised of (1) any other outcomes from investigations into the Unwanted Medicine boxes and liners; (2) any reports the Vendor makes regarding the boxes and liners to law enforcement or government agencies; (3) any law enforcement or government agency involvement with the boxes and liners; (4) any legal proceedings involving this boxes and liners; and (5) any additional changes in policy or procedure that the Vendor has or is planning to make as a result of these events.

Whether Any Law Enforcement or Regulatory Agencies Involved: None. There were no litigation, arbitrations, or other legal proceedings arising out of, or involving, the incident.




Figure 6: MED-Project Brochure Front (Chinese)




Figure 16: MED-Project Kiosk Poster (English)




Figure 17: MED-Project Kiosk Poster (Spanish)




Figure 21: MED-Project Combo Poster (English)




Figure 22: MED-Project Combo Poster (Spanish)




Figure 24: MED-Project Combo Poster (Tagalog)






Figure 28: MED-Project Website Landing Page (December 2023)




Figure 29: MED-Project Website – Medicine & Sharps Usage Page (December 2023)




Figure 30: MED-Project Website – Safe Storage Information Page (December 2023)




Figure 31: MED-Project Website – Find A Location Page – Convenient Locations Tab (December 2023)




Figure 32: MED-Project Website – Find A Location Page – What Can I Dispense Of? Tab (December 2023)




Figure 33: MED-Project Website – Find A Location Page – Location Services Tab (December 2023)




Figure 35: MED-Project Website – Medication Mail-Back Package Insert Page (December 2023)




Figure 37: MED-Project Website – Learn Page (December 2023)




Figure 38: MED-Project Website – Brochure – Medicine Program Page (December 2023)




Figure 39: MED-Project Website Learn Page – Video Public Service Announcement (PSA) (December 2023)




Figure 42: MED-Project Website – Contact Page (December 2023)
