The Alameda County Department of Environmental Health, Solid/Medical Waste Management, the Local Enforcement Agency (LEA) for the Department of Resources Recycling and Recovery (CalRecycle), is providing this public notice as part of the process to consider a modification of the Solid Waste Facility Permit (SWFP) for **Altamont Landfill & Resource Recovery Facility**. This public notice was prepared pursuant to Title 27, California Code of Regulations (27CCR), Section 21660.3.

Project Description:

Altamont Landfill & Resource Recovery Facility is an existing landfill operating under a full SWFP issued on August 22, 2005. The application package to modify the SWFP proposes the following:

- Decrease of landfill site acreage from 2,170 to 2,063.6 acres.
- Update the estimated closure date from 2025 to 2070.
- Update the Joint Technical Document (JTD) to reflect the current operations.
- Update the permits and approval dates in the JTD and SWFP.
- Update the site layout to reflect the current locations of the operations.

LEA's Determination:

On April 13, 2020, Altamont Landfill & Resource Recovery Facility submitted the application package for a modified SWFP and was accepted as complete and correct by the LEA on May 8, 2020. The LEA's preliminary determination is that the proposed changes are nonmaterial and that the SWFP does not need to include further restrictions, prohibitions, mitigations, terms, conditions or other measures to adequately protect public health, public safety, ensure compliance with state minimum standards, or to protect the environment, pursuant to Title 27, California Code of Regulations, Section 21665(d). The LEA's preliminary determination is that the proposed changes are also consistent with their operating document.

Purpose of the Public Notice:

This Public Notice is for all parties interested in providing comments on the LEA's proposed action for a modified SWFP. Prior to the issuance of the SWFP, the LEA must request and receive concurrence from CalRecycle. If you wish to be notified of the CalRecycle meeting, please notify the LEA in writing no later than June 19, 2020.
