The Alameda County Department of Environmental Health, Office of Solid/Medical Waste Management, Local Enforcement Agency (LEA) for the Department of Resources Recycling and Recovery (CalRecycle), is providing this public notice as part of the process to consider a revision of the Solid Waste Facility Permit (SWFP) for Bee Green Recycling & Supply, LLC. This public notice was prepared pursuant to Title 27, California Code of Regulations (27 CCR), Section 21660.3.

The Incomplete Application Package was submitted by Bee Green Recycling & Supply, LLC on July 12, 2019 and was accepted by the LEA on July 24, 2019. The LEA determined that the proposed change is a significant change as defined in Title 27, California Code of Regulations, Section 21563(d)(6) and requires a revised solid waste facilities permit. The Permit Revision Application was accepted as complete and correct on November 25, 2019.

This informational meeting (in compliance with Public Resources Code Section 44004) is for all interested parties to ask questions and provide comments on the proposed Revised SWFP. Comments may be submitted prior to the meeting, directly to Javier Magana and Jane Auyeung by postal mail or email. The meeting is strictly informational, and no official decision will be made at the meeting regarding the formal determination on the SWFP application.

Project Description:

Bee Green Recycling & Supply, LLC is an existing transfer/processing facility operating under a full SWFP issued on January 11, 2016. The application package to revise the SWFP proposes the following:

- Increase the Transfer / Processing / Maintenance Operating Hours from 2:00am to 11:59pm (22 hours per day), 7 days a week to 24 hours per day, 7 days a week.
- Discontinue receiving source-separated green materials.
- Discontinue mixing and grinding green materials and wood waste to produce biofuel.
- Update the site layout to reflect the current locations of the material stockpiles, processing areas, and location of the hazardous waste container.

Purpose of the Meeting:

This Public Informational Meeting is for all interested parties to learn more about the proposed permit and to provide comments to the LEA regarding the proposed action(s). The applicant waived the statutory time limit contained in Public Resources Code Section 44008. On November 25, 2019, the LEA determined that the application met the requirements of 27 CCR, Section 21570. Prior to the issuance of the SWFP, the LEA must request and receive concurrence from the Department of Resources Recycling and Recovery (CalRecycle). If you wish to be notified of the CalRecycle meeting, please notify the LEA in writing no later than January 3, 2019.
