HOST of PUBLIC MEETING: Alameda County LEA

The Alameda County Department of Environmental Health, Solid/Medical Waste Management, the Local Enforcement Agency (LEA) for the Department of Resources Recycling and Recovery (CalRecycle), received an application for a Solid Waste Facility Permit (SWFP) Revision for Vasco Road Landfill (VRL) on November 11, 2022. The application was deemed Complete and Correct and accepted for filing on December 9, 2022. This informational meeting is for all interested parties to ask questions and provide comments on the SWFP Revision Application. Comments may be submitted prior to the meeting, directly to Ms. Wing Suen by mail, email, or fax. The meeting is strictly informational, and no official decision will be made at the meeting regarding the formal determination on the SWFP Revision application.

Project Description:

Vasco Road Landfill (VRL) is a Disposal Facility (Facility). The application package submitted by VRL is for a SWFP Revision that proposes the following:

- The Facility will increase the maximum landfill elevation from 1,025 feet to 1,170 feet above mean sea level;
- The estimated landfill closure year will change from 2022 to 2051;

• The design capacity will change from 32.97 million cubic yards (mcy) to approximately 40.21 mcy whereas the hours of operation, maximum daily tonnage, traffic volume, and permitted acreages will remain the same.

Purpose of the Meeting:

This Public Informational Meeting is for any interested parties to learn more about the proposed SWFP Revision and to provide comments on the LEA's proposed action for a revised SWFP. The decision to issue or not to issue the revised SWFP must be made by the LEA within 120 days from the date the application was deemed Complete as required by Statute. Prior to the issuance of the revised SWFP, the LEA must request and receive concurrence from CalRecycle. If you wish to be notified of the CalRecycle public meeting at which it will consider whether to concur on the LEA's proposed SWFP, please notify the LEA in writing no later than January 9, 2023.

This public meeting will be hosted by the LEA, pursuant to Title 27, California Code of Regulations (27 CCR) Sections 21660.2(a) and 21570(g).
